holds degrees in industrial and organizational psychology and applied psychology from Wayne State University (Detroit, Michigan) and California State University, Long Beach.

Radner said that he had been impressed that during this period of unprecedented membership growth, HPSJ was awarded a prestigious NCQA Accreditation. The National Committee for Quality Assurance (NCQA) in June 2015 awarded HPSJ a Three-Year Health Plan Accreditation for its Medicaid/HMO line of business (Medicaid is known as Medi-Cal in California). The NCQA award recognizes HPSJ as “ACCREDITED for service and clinical quality that meet or exceed NCQA’s rigorous requirements for consumer protection and quality improvement.”
