Dear Health Plan of San Joaquin Contracted Provider,

Health Plan of San Joaquin (HPSJ) is pleased to announce that it is preparing to implement the Department of Health Care Services (DHCS) Value Based Payment (VBP) program, funded by Proposition 56. The funding allocation for the VBP program is contingent upon DHCS VBP program approval, which is currently in a draft state. HPSJ is unable to execute the VBP program payments until the State finalizes this approval but can prepare our provider network in anticipation of this approval.

#### WHAT'S THE VBP PROGRAM?

VBP program will provide incentive payments to providers for meeting specific measures aimed at improving care for certain high-cost or high-need populations. Incentive payments are for VBP measures in the following areas:

- Behavioral Health Integration
- Chronic Disease Management
- Prenatal/Post-Partum Care
- Early Childhood Prevention

#### THE VBP PROGRAM EXCLUSIONS

Beneficiaries with Medicare Part B, and encounters occurring at Federally Qualified health Centers (FQHCs), Rural Health Clinics, American Indian Health Clinics, and Cost Based Reimbursement Clinics will be excluded from payment.
