## **Community Reinvestment Approval Resolution**

RESOLUTION TITLE: Community Reinvestment Approval

RESOLUTION NO.: 2023-05

WHEREAS, the San Joaquin County Health Commission ("Commission") is committed to achieving greater levels of access to barrier-free quality care in all communities served by the Health Plan; and

WHEREAS, the Commission defines Quality as improving the health of our members by ensuring they see their healthcare providers for preventative care including immunizations, screenings for early detection of serious health conditions, and to manage their current health concerns. We believe this will help our members stay healthy and create healthier communities. The Health Plan recognizes that some communities face significantly more socioeconomic barriers than others, preventing them from living their highest quality of life possible. The Health Plan will develop and implement strategies to eliminate such barriers, making it possible for all of its members to become, and remain as healthy as possible.

WHEREAS, the Commission committed \$100 million for the Community Reinvestment Program on June 28, 2023; and

WHEREAS, the Commission acknowledges the Californian Department of Health Care Services 2024 contract requirements exist for community reinvestment when (a) net income is achieved by a Medi-Cal Plan or (b) state-established quality thresholds are not achieved for the plan and its delegates and sub-delegates, and is following our Annual Community Reinvestment Strategy, Plan, and Reporting (CRSPR) policy approved January 25, 2023; and

WHEREAS, the Commission established a Community Reinvestment Committee to design, plan, and implement a Community Reinvestment Plan that aligns with its mission, vision, values and community priorities; and

WHEREAS, the Commission's Community Reinvestment Plan's Goals and Areas of Focus will serve as guardrails for the Health Plan's community reinvestment approach which will direct the investment of \$100 million committed by the Commission in June 2023; and

## San Joaquin County Health Commission Community Reinvestment Plan Executive Summary

The San Joaquin County Health Commission's Community Reinvestment Plan is designed to enhance six areas of focus, ranging from healthcare access to quality for its members, encompassing the Health Plan of San Joaquin (HPSJ) and the forthcoming Mountain Valley Health Plan (MVHP), referred to collectively as Health Plan. This plan provides a roadmap for driving transformative progress within the communities served by our Health Plan, which is rooted in the core values of the Health Plan.

Based on internal and external data sources—e.g., service area-specific Community Health Needs Assessments (CHNAs) and Community Health Improvement Plans (CHIPs), the following delineates the identified Community Reinvestment Plan Areas of Focus:

**Quality** is improving the health of our members by ensuring they see their healthcare providers for preventative care including immunizations, screenings for early detecting of serious health conditions and to manage their current health concerns. We believe this will help our members stay healthy and create healthier communities.

At the heart of this Community Reinvestment Plan lies the recognition of the influential role played by social determinants of health. These non-medical factors profoundly impact health outcomes and addressing them is essential to promoting access to barrier-free quality care and improving the well-being of the community. In alignment with the California Department of Health Care Services' Advancing and Innovating Medi-Cal (CalAIM) initiative, this plan seeks to tackle complex challenges facing California's most vulnerable residents, transforming the Medi-Cal program, and improving healthcare delivery, programming, and payment approaches. It is committed to implementing local strategies that address these challenges and promote access to barrier-free quality care within the communities served by the Health Plan.

The plan outlines clear goals, focusing on increasing the number of healthcare providers, empowering community-based organizations, ensuring data accessibility, and enhancing the quality of care provided to members. These objectives are strategically aligned with the broader mission and vision of the Health Plan. In alignment with its mission and vision, the Health Plan defines community reinvestment as a grantmaking approach that supports innovation within the local public health system to improve the local Medi-Cal delivery system.

The following details the goals of this Community Reinvestment Plan:
