

# HIE Grants Incentive Program

Available for HIE & Standard Data Sharing



Health Plan of San Joaquin/Mountain Valley Health Plan ("Health Plan") has earmarked \$8.775 million in Community Reinvestment funds to bolster data sharing initiatives aimed at strengthening the connection between healthcare providers and the Health Plan-supported Health Information Exchange (HIE). These funds are designed to streamline the integration of healthcare providers into the Health Plan-supported HIE or Standard Data Sharing Templates for treatment, payment and operations.

#### **DSA Signatory Grants**

DSA Signatory Grants Round 3 applications open January 1, 2024, and run through June 30, 2025. DSA Signatories who demonstrate that additional technical or technological capabilities are needed to meet their DSA requirements are eligible to apply for either a **Technical Assistance** grant or a QHIO Onboarding grant.

*Important:* Applicants, or organizations included under an umbrella application must have signed the DSA before submitting their grant application.
